2. The 1st instalment is the 20% of the approved Central Assistance (Rs. 862.80 Crore) towards project fund under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for implementation of projects related to Water Supply, Sewerage, Drainage, Urban Transport (Non-Motorised) and Parks approved in SAAP-II. The total approved size of State Annual Action Plan (SAAP) -II of Madhya Pradesh is Rs. 2050.90 Crore for 2016-17.

3. The first instalment has been released on the basis of estimated project cost and any excess or shortfall in the first instalment shall be adjusted while releasing the second instalment of Central Assistance based on approved cost.

4. Diversion of Central Grants for purposes other than the Mission projects is not allowed and shall entail levy of penal interest on the amount and any other action by the Apex Committee and may include adverse effect on release of grants.

5. As per the provision of the Mission's Guidelines, State Government is required to release the Central Assistance funds along with State share to the ULBs within one month of release of Central share by the Ministry otherwise interest at the rate specified by the Ministry of Finance shall be levied on the State for delay and appropriate deductions made from future instalments.
